Resolution to Address Transportation Costs for NYU Students

WHEREAS, Students often overlook the cost of transportation when calculating the price of attending college whether it is subway, car, or bus.

WHEREAS, At NYU, on/off-campus student students pay on average \$1,132.1

WHEREAS, 94% of all commutes involved public or self-powered modes of transportation with 41% coming from the subway.²

WHEREAS, NYU's community members span the entire tri-state area. Since 2009, the NYU community has spread further across the city. In particular, neighborhoods like Bushwick, Bay Ridge, and Long Island City have seen significant increases.³

WHEREAS, As NYU's Downtown Brooklyn location has grown, so has the share of the community living in Brooklyn (from 14.3% up to 20.3%). The community has also spread out beyond Manhattan and Brooklyn, with all outer boroughs and NYC suburbs showing modest increases.⁴

WHEREAS, Excessive transportation costs can not only impair students' academic performance but also increase the amount of time it takes for students to graduate if they graduate at all.⁵

WHEREAS, CUNY estimates that students should count on needing at least \$9,600 for personal expenses; of that amount, most students spend as much as \$1,300 during a nine-month period on transportation costs alone.⁶

WHEREAS, An unlimited 30-day MetroCard costs \$127 per month, \$1,524 per year for those who make the purchase each month.⁷

WHEREAS, Mayor de Blasio implemented the new Fair Fares program that provides half-priced MetroCards to residents already receiving public assistance from the city.⁸

WHEREAS, City Council Speaker Corey Johnson said "The turnstile can be the door to unlimited opportunity if you can get on, and we are just giving you the keys to open that door," regarding the Fair Fares program.⁹

WHEREAS, Los Angeles County Metropolitan Authority's U-Pass program with 15 college and university partners; and the City Colleges of Chicago's Ventra U-Pass program for full-time students.^{10,11}

WHEREAS, MTA Long Island Rail Road and Molloy College have partnered to provide the first-ever discounted college ticket initiative for full-time students traveling to and from campus on the LIRR.¹²

WHEREAS, Many other cities — including Sacramento, Chicago, Philadelphia, San Francisco, and Kansas City — offer free fares for students.

WHEREAS, Free and reliable transportation can help improve a student's attendance and academic performance.¹³

WHEREAS, American University partnered with WMATA to launch the pilot UPass program for the 2016-2017 school year. The UPass program costs AU students \$130 a semester, or \$1 each day.

WHEREAS, A Washington Post Report concluded such a discount could make up for decreased ridership and boost revenue without hiking fares.¹⁴

NOW IT BE RESOLVED, NYU works with the Washington Metropolitan Area Transit Authority (WMATA) to include NYU-DC in the U-pass program.¹⁵

NOW IT BE RESOLVED, NYU's Office of University Relations and Public Affairs partners

with the MTA and other transit agencies to provide students with unlimited rides through "university-negotiated fare bundling." Under the plan, NYU bargains for reduced fares from the local transit agency and purchases passes for the entire student body, which students then pay in their student-activity fee.¹⁶

NOW IT BE RESOLVED, NYU administrators alongside student leaders work with the MTA

to implement a pilot program for commuter students for a universal pass under the premises of

fare bundling.

AND FINALLY BE RESOLVED, NYU makes it a mandatory student fee, it is considered part

of the cost of attendance and included in overall cost calculations for financial aid.¹⁷
